Monthly Summary for the month of March, 2018

Important events for the month of March, 2018 are as follows:

- 1. During the month, Brahmaputra Cracker & Polymer Limited (BCPL) has produced 26,766 MT of Polymer and 5,268 MT of Liquid Hydrocarbon. 23,236 MT of Polymer and 4,298 MT of Liquid Hydrocarbon have been sold during the month. The plant achieved 119% capacity utilization during the month which is the highest ever capacity utilization achieved so far. The average capacity utilization of the plant in the financial year 2017-18 is around 78%.
- 2. In terms of MoU parameters like production and sales, reduction in specific energy consumption, human resource development etc., BCPL has achieved "Excellent" MoU target for the year 2017-18. The MoU for the year 2018-19 has been signed between BCPL and GAIL, as per DPE's guidelines.
- 3. BCPL celebrated the National Safety Week during the month to commemorate the establishment of the National Safety Council and to enhance safety awareness among employees.
- 4. As on 31.03.2018, Central Institute of Plastics Engineering and Technology (CIPET) has trained 70,056 persons (13,849 through long term training programmes and 56,207 through short term training programmes) under its Skill Development Programme.
- 5. The status of disbursement of pro-rata compensation and ex-gratia to Bhopal Gas victims is as under:
 - Pro-rata compensation in the ratio of 1:1 of the original compensation has been paid to the tune of Rs 1517.70 crore in 5,63,091 cases till March, 2018.
 - ii. The disbursal of ex-gratia is continuing. An amount of Rs. 2.71 crore has been awarded to 118 claimants during the month of March 2018.
- 6. A workshop on 'Early Cancer Detection (Cervical and Breast Cancer)' was organized for the women officers/employees of the Department on 8th March, 2018, on the occasion of International Women's Day. 30 women employees of the Department, of all levels, participated in the Workshop.
- 7. Ministry of Personnel, Public Grievances and Pension has issued a Certificate of Appreciation on 14th March, 2018 in recognition of the commendable work done by the Department of Chemicals & Petrochemicals in implementation of e-Office.
- 8. In the month of March, 2018, 07 grievances were brought forward and 34 grievances received, of which 27 have been disposed. Out of the remaining 14 grievances, none is of more than 90 days pendency.
