Subject: Public Procurement (Preference to Make in India) Order 2017 – Revision regarding.

Ref. (I) Department for Promotion of Industry and Internal Trade (DPIIT) Order No.P.45021/2/2017-B.E.II dated 15.06.2017 and its revisions dated 28.05.2018, 29.05.2019, 04.06.2020 and 16.09.2020.

Ref. (II) Department of Chemicals & Petrochemicals orders dated 25.05.2018, 23.10.2018 and 13.03.2020 and 01.06.2020.

The Government has issued Public Procurement (Preference to Make in India) Order, 2017 vide DPIIT Order No. P-45021/2/2017-B.E.-II dated 15.06.2017 and subsequent revisions vide Orders No. 45021/2/2017-PP(BE-II) dated 28.05.2018, 29.05.2019, 04.06.2020 and 16.09.2020 to encourage "Make in India" and to promote manufacturing and production of goods, services and works in India with a view to enhance income and employment. The Department of Chemicals and Petrochemicals has issued Orders No. C.I.-43012/52/2017-Chem-I(B) dated 25.5.2018, 23.10.2018, 13.03.2020 and 01.06.2020 for chemicals and petrochemicals in accordance with the DPIIT Orders issued as referred above. In view of the revised order issued by DPIIT on 16.09.2020, the Department now rescinds the earlier orders and hereby notifies this order in furtherance of the DPIIT Orders referred above with immediate effect.

2. In respect of the 28 chemicals and petrochemicals indicated below, based on available data, Department has concluded that there is sufficient local capacity and local competition and only Class-I local suppliers will be eligible to bid in respect of these 28 items indicated below irrespective of purchase value:-

Every procuring entity shall constitute a Committee with internal and external experts for independent verification of self-declaration and auditor's/accountant's certificates on random basis and for the complaints that are received/referred. In case any clarification is needed by the Committee on any particular point, the matter may be referred to the following Committee in the Department of Chemicals & Petrochemicals:-
