#### I. COMPANY PROFILE

Hindustan Organic Chemicals Limited (HOCL) was incorporated under the Indian Companies Act, 1956 with the objective of setting up for chemicals manufacturing units for production of organic chemicals and chemical intermediates. It is a Schedule 'B' CPSE, listed on BSE and is with the administrative jurisdiction of Department of Chemicals and Petrochemicals under the Ministry of Chemicals & Fertilizers. The Company has two units viz. at Rasayani, District Raigad, Maharashtra and at Ambalamugal, Kochi, Kerala. As per the restructuring plan for HOCL approved by the Govt. of India on 17 May 2017, the operations of Rasayani unit have been closed down. In addition, M/s. Hindustan Fluorocarbons Limited at Hyderabad is the Subsidiary of HOCL. The Govt. of India has approved closure of HFL on 22.01.2020.

The company employed 257 regular employees (Executives122, Non-executives 135) as on 31.03.2020.

Its Registered and Corporate Office is at CBD Belapur, Navi Mumbai, Maharashtra.

The authorized and paid up capital of the Company was Rs.370 crore and Rs.337.27 crore respectively as on March 31, 2020.

The shareholding of the Government of India in the company is 58.78%.

### II. JOB DESCRIPTION AND RESPONSIBILITIES

Director (Finance) is a member of Board of Directors and reports to Chairman and Managing



Director. He/She is in overall charge of finance and accounts functions of the organization, and is responsible for evolving and formulating related policies and their implementation.

#### III. ELIGIBILITY
