Note .- The departmental Assistant Industrial Advisers in Level-10 (Rs.56,100-1,77,500) in the pay matrix with five years regular service rendered after appointment thereto in the grade will also be considered along with outsiders and in event of his selection to the post, the post shall be deemed to have been filled by promotion.
