I. COMPANY PROFILE

Hindustan Insecticides Limited (HIL) was incorporated in 1954 for manufacturing DDT and its formulations for meeting the demand of National Malaria Eradication Programme launched by the Govt. of India. The company has also diversified into agro business over a period of time. Apart from public health, presently the company is operating in all the three key agro inputs i.e. agro chemicals, seeds and fertilizers. HIL is a profit making Schedule "C" CPSE in the Chemical Sector under the administrative control of Department of Chemicals & Petrochemicals.

The authorized and paid up capital of the Company was Rs. 100 crore and Rs. 91.33 crore respectively as on March 31, 2016.

Its Registered and Corporate offices are at New Delhi.

The turnover of the company for the financial year 2014-15 was Rs. 340.27 crore.

The shareholding of the Government of India in HIL is 100%.

II. JOB DESCRIPTION AND RESPONSIBILITIES

The Chairman and Managing Director is the Chief Executive of the Corporation and accountable to its Board of Directors and Government/Share holder. He is responsible for the efficient functioning of the Corporation, and for achieving its corporate objectives and performance parameters.

2. EMPLOYMENT STATUS:
