- II. Brief discussion held among the participants regarding the cloud infrastructural setup and their requirements for the project and its applicability

2. Regarding the appointing of the database management company, chairman directed that that no subletting will be allowed for the appointment of the agency for cloud infrastructure provided as per the guideline of the MeitY

3. Chairman directed that NIC may explore the best feasibility of the bidder with the current requirements on the technical grounds to verify the authenticity of the submissions of the bidder. NIC can go through the verified procedure to check the hosting portal, issue of licenses, costing, etc.

4. Chairman further informed that the contract will be of particular 3 years with full proper regulations authorised for payments with proper verification depending upon the work of the company appointed.

5. At last, DDG informed submission should strictly be verified by the list provided of the 18 listed companies provided by Miety.
