(a) The firm should be in existence for over 5 years in Central/State Govt. offices/PSU with the maintenance business (service business turn over) of more than Rs. 20 lakhs per annum during the last 3 years. Documentary proof like balance sheet & Income. Tax return etc. should be attached.

(b) The firm must be registered with the Registerar of Companies and with the Delhi Sales Tax Department. VAT No. / Service Tax No. is to be given.

(c) A firm black listed by any Govt. Office will not be eligible to participate in this tender. An undertaking to this effect will have to be given at the time of submitting the tender.

(d) The quotations should be accompanied by an 'Account Payee' Demand Draft of 10,000/-(Rupees ten thousand only) in favour of PAO, Department of Chemicals and Petrochemicals. New Delhi as E.M.D. The quotations without E.M.D. will not he entertained, Earnest Money Deposit of unsuccessful bidders will be returned to them at the earliest.

5. The job will be entrusted to the sucessful tenderer under the General Terms & Conditions mentioned below:

i. This tender is for comprehensive Annual Maintenance Contract (CAMC) of Servers/Computers/Printers/UPSs etc. therefore firm shall bear cost of all spare parts of related items excluding only consumables like toner, Ink Cartridge & Floppies, batteries etc.

ii. The vendor will provide two resident engineers on all working days from 9.00 AM to 6.00 PM. The engineer should be equipped with Mobile phones to ensure their availability.

iii The awardee has to provide services in Shastri Bhawan, Udyog Bhawan, Janpath Bhawan and residence of Senior Officers of this Department and Residential Office of Minister.

iv. This Department reserves the right to reduce or increase the number of items offered for maintenance contract during the currency of the AMC.

v. It shall also be the responsibility of the contractor to ensure that all the equipment under contract are in working condition during the entire period of contract as well as at the end of the contract period. Apart from the normal maintenance the cost of parts, it any, will be borne by the Department

vi. It may particularly be noted that after the contract is awarded, the contractor will be required to fix all the maintenance problems in question, bring the equipment in perfect working order so that these are ready for use before the commencement of the next session. The contractor will be required to depute a whole time expert mechanic/engineer on duty exclusively for this Department on all working days to attend the maintenance requirement for computers, printers, scanners, fax & UPS whenever defect arises therein.

vii. The work is to be carried out in the office premises itself. However, only such work as cannot be done in the office premises will be allowed to be done outside with written permission of the Section Officer, Administration Section of the Department and no extra payment would be made on this account.

vii Failure to repair/service the equipment in question within the reasonable time. without adequate reasons or to return the repaired machine within a week's time at the maximum, may entitle proportionate deductions in the bill of the total period.

viii. The successful tenderer will be required to furnish a "Security Deposit" @ 5% of the total value or the contract. The security deposit shall be in the form of Demand Draft in favour of PAO, Department of Chemicals and Petrochemicals. New Delhi. Security deposit will be refunded only after the expiry of the contract- The security deposit will be forfeited if during the period of contract, the services of the contractor are found unsatisfactory in any respect or if any of the condition of the contract is contravened towards any damage due to negligence on the part of the contractor., besides any action that may have to be taken against the contractor.

ix This Department will not provide any conveyance/vehicle for servicing of computers etc. for the offices located outside Shastri Bhawan.

x If the work of the contractor is found unsatisfactory or if the contractor dishonours the contract, the job will be entrusted to any other firm at the risk and expense of the defaulting contractor.

xi. The contract is liable to be terminated summarily by this Department at any lime if the work of the contractor is found unsatisfactory. The decision of the
