LIMITED TENDER NOTICE

In continuation of Limited Tender Notice of even number dated 10.5.2023, I am directed to say that Quotations in sealed cover are invited from the firms for Hiring/Engaging the services/dedicated one Manpower of Experts from CERT-in empanelled agencies for cyber security compliance for one year. 'Scope of work' to be done is indicated in the annexure attached. Terms and conditions are as follows:-

- a. Tenders from only those firms will be entertained which are registered in CERT-in and have Service Tax Number, GST and PAN No. The quotation must be submitted in the proforma given at Annexure-I and Annexure-II
- b. The successful bidder would have to deposit an amount of 3% of total tender value as security deposit in the form of Bank Guarantee drawn in favour of Pay and Account officer, Department of Chemicals and Petrochemicals, New Delhi.
- c. Advance payment will not be under any circumstances.
- d. During the period of contract the firm will have to depute a qualified person for doing the work as per work of scope.
- e. The Department reserves the right to terminate the contract at any time without assigning any reason there for.
- f. The tender should be accompanied with the Earnest Money Deposit of 25,000/- in the form of DD/ Pay order from any of the Nationalized Bank in favour of P&AO(Sectt.), Department of Chemicals and Petrochemicals, New Delhi.
- g. Tenders may please quote their unconditional rates and it shall be ensured that there are no cutting/overwriting in the tender form. The price quoted at the time of submission of tender should remain valid for 45 days from the date of tender opening and the rates finalized on the basis of these prices shall remain in force during the currency of the contract which will normally be for a period of one year. It may specifically be noted that no changes/escalations in the accepted rates shall be allowed during currency of the contract.
- h. The agency shall be responsible for payment of wages/settlement of dues with workers engaged by the firm as per prevailing labour/wage laws in force in NCT of Delhi and the Department of Chemicals and Petrochemicals shall not be a party to any dispute between the agency and workers.
- The agency shall arrange to get the character and antecedents of workers verified from Police authority before deployment and their full particulars shall be furnished to the Department of Chemicals and Petrochemicals.
- j. The Prospective bidders are free to seek any clarifications/see the kind of requirements, the Department is looking for. Under Secretary (Admn.), R. No. 434-C, Shastri Bhawan, New Delhi-110001(Telephone No. 23386013) may be contacted with prior appointment on any working day before tender opening.
- k. The contract shall normally be awarded to the lowest evaluated bidder whose bid has been found to be responsive and who is eligible/qualified to perform the contract satisfactory as per the terms and conditions incorporated in the tender letter. The Department reserves the

option to select more than one firm for award of contract to ensure uninterrupted service during the currency of the contract.

- If any of the bidders have any objection with regard to the terms and condition of the tender, 1. the same may be pointed out with 10 days of the issue of the tender documents.
- m. Proof of Income Tax Assessment for the last three years.
- n. Documentary proof of financial turnover of Rs. 50 lakh per annum for the last 3 years.
- o. Copy Income tax return for last three years to be enclosed.
- p. Documentary proof of allotment of Service Tax No, PAN/GST No. etc. by the concerned Government offices.
- q. Experience of person deployed by agency should be Graduate BE/B.Tech and Postgraduate - MCA/MTech with specialization in computers /Electronics /IT or M.Sc.in CS/IT/Physics/Mathematics/Stats / Electronics for more than 3 to 6 year in central State Department/Ministries or government undertaking.
- Bid Security for 10,000/- in the form of a Bank Draft/Demand Draft pay order issued by a r. scheduled bank in favour of Pay & Accounts Officer, Department of Chemicals and Petrochemicals, New Delhi.
- 3 The bids are to be submitted in two Parts:
